Description of Change

CPC is building a new facility in Arden Hills, Minn. We will move operations for medical, industrial, and thermal management product lines from our 2820 Cleveland Avenue, Roseville, Minn., facility to the new facility. The move will occur gradually over many weeks beginning in December so as to minimize risk and interruptions to your deliveries. We will produce product at the Roseville facility as we shift production to the new facility. The Roseville facility will remain operational and will be dedicated to CPC's BioPharma business unit. **We do not anticipate delivery interruptions for any product lines.**

Affected Products

Product lines designed to support medical, industrial, and thermal management applications. See Appendix A for impacted product lines.

Reason for Change

To accommodate CPC's continued growth.

Implementation Date

We will begin moving equipment in December. We expect the new facility to be fully operational in January 2023. We will provide notice to you and our freight vendors when we shift the shipping location from Roseville to Arden Hills. The transition should be seamless to you and your shipments.

Additional Information

At the new facility CPC will continue with quality system certifications to ISO 9001:2015 and ISO 13485:2016. The only quality-system impacting changes will be the movement of existing equipment from the current facility at 2820 Cleveland Ave to the Arden Hills facility. There will be **no changes to:**

- Suppliers of purchased components
- Component or finished goods design
- Manufacturing equipment or processes
- Production employees
- Quality system
- Packaging or labeling

CPC will execute an Installation Qualification (IQ) on all equipment moved to ensure no change in functionality as a result of the move. We also will perform specific Performance Qualification (PQ) runs to manufacture representative finished-goods to demonstrate the moved work cell(s) continue to manufacture parts meeting CPC's specifications.

Products' traceability, including manufacturing location, will be identified through lot numbers. Once equipment has moved and Roseville-manufactured inventory is depleted, CPC will no longer make those products available from the Roseville facility.

The new facility will also feature an additional ISO Class VII cleanroom will be certified to ISO 14644-1. Following certification CPC will undergo a third party audit for this cleanroom manufacturing space.
